Date & Time

The market is held on Thursdays from 3:00pm-6:30pm. Weekly markets will begin on Thursday, May 11th, 2017, and end for the season on October 19th, 2017.

Location

The Mt. Horeb Farmers' Market is held at 315 E. Main Street on the lawn of the Evangelical Lutheran Church in downtown Mt. Horeb.

Fees

- The full season (24 weeks) fee is \$120.00, payable with this application.
- A partial season fee is \$60.00 for 10 consecutive weeks, payable with this application. If choosing this option my ten weeks of attendance will be:

- The weekly vendor fee is \$10.00 per day, payable at the beginning of each market.

**Liability Insurance**

Vendors are required to provide proof of liability insurance as a condition for selling at the Mt. Horeb Farmers Market. Your insurance agent can give you a one-page “Certificate of Insurance.” It must show coverage of no less than \$100,000, and list the vendor's name and address. This certificate should be included with your application. No vendor will be permitted to vend without this Certificate of Insurance.

**Covenant to hold harmless.**

The vendor agrees to indemnify and save Evangelical Lutheran Church of Mt. Horeb and the Mt. Horeb Farmers' Market harmless against and from any and all claims, damages, costs and expenses, including reasonable attorney’s fees, arising from the conduct or management of the business conducted by vendor at the Mt. Horeb Farmers’ Market.

**Loss or damage of property.**

Evangelical Lutheran Church of Mt. Horeb and the Mt. Horeb Farmers Market shall not be liable for any damage to property of vendor or of others located on the leased stall, nor for the loss of or damage to any property of vendor or of others by theft or otherwise.
